## HYC Member Request For Access

**This Agreement** is made on \_\_\_\_\_, 20\_\_\_\_ by and between the  
Dolphin Bay Owners' Association at 7102 Dolphin Bay Blvd., Panama City Beach, FL

Guest hereby requests entry to Dolphin Bay via the use of a clicker for access to the  
Harbourage Yacht Club (HYC). Access is for personal use only; no other persons,  
businesses, or otherwise may use the Gate Access Clicker for entry to Dolphin Bay.

**Guest will provide copy of proof of ownership (registration), proof of insurance and  
license tag number for personal vehicles used to access Dolphin Bay.**

Guest agrees that access to Dolphin Bay and the Harbourage Yacht Club is only granted  
while Guest is a member in good standing of the HYC. Members of the HYC not in good  
standing with the HYC, or with the Dolphin Bay Owners' Association (DBOA) will incur  
deactivation of their Gate Access Clicker until such time that the DBOA deems the member  
to have restored good standing.

Guest recognizes and accepts that it is his/her responsibility to review, understand, and abide  
by the rules of the HYC, as well as the DBOA *Initial Use Restrictions and Rules* of the  
CC&R documents found at www.dolphinbaypcb.com.

Guest will only use the Gate Access Clicker for access to their vessel at the HYC and only in  
accordance with HYC policies and DBOA policies.

Guest agrees to pay any and all costs to repair damage to property of Dolphin Bay or its  
residents that is caused by the Guest (i.e., gate arms, sidewalks, yards, common areas, etc.)

Guest agrees that the DBOA or its representatives are not responsible for any damage to or  
theft of their property while in Dolphin Bay, or at the HYC marina. No representations are  
made guaranteeing or implying security within Dolphin Bay or at the HYC marina.

DBOA owns and maintains the gate house and gate operator system and agrees to provide the  
Guest with a Gate Access Clicker for a fee.

Guest agrees to pay a \$40 fee for a Gate Access Clicker and an additional \$40 for  
replacement of any lost, stolen, or damaged Gate Access Clickers.

This agreement will be enforced under the laws of the state of Florida.
